

Terms of Service

Fees:

Services will be recurring and will be automatically re-billed on the same business day of each following month for any and all amounts owing under this Agreement unless written cancellation has been received according to the Cancellation Policy.

Cancellation Policy:

You (the customer) may cancel your order for services at any time according to the following:

- a) Cancellations must be in writing by sending an e-mail to cancel@internetads4less.com and must be received at least 7 days prior to the automatic monthly billing date in order to avoid billing.
- b) Upon confirmation and acknowledgment of your cancellation request, all services will be cancelled at the end of your current billing cycle.
- c) Written cancellations not received in writing at least 7 days prior to the monthly billing date are not binding and will incur the full monthly advertising cost. Services will be cancelled at the end of the next billing cycle.
- d) Under no circumstances will credit or refunds be given for partial month service. Set up fees are non-refundable.

Account Information:

You (the customer) must promptly update your account information with current and accurate information. Failure to do so may result in your services immediately being discontinued, without liability, until such information is provided and/or terminate this Agreement.

Termination:

If you (the customer) have not paid all owing amounts when due, your services may no longer be provided.

This Agreement and/or your services may be terminated immediately at anytime without advance notice for your breach or default of any obligation set forth in this Agreement or if it is determined, in our sole discretion, that your business practices are detrimental to the achievement of our business objectives. In such event, you shall be provided with an electronic notice of termination.

General Information:

All notices to you shall be given electronically, sent to the electronic mail address provided by or for you during registration for services or as updated on your account.

The fee schedule may be amended after providing you with a thirty (30) day electronic notice. Any fee schedule updates must be accepted electronically by you in order to continue receiving services.
